

West Ridge Group LLC – Data Subscription Agreement (EULA)

Non-Sensitive Data Subscription Agreement

Last Updated: November 2025

This Data Subscription Agreement (“Agreement”) governs Subscriber’s access to and use of the Data provided by Westridge Group LLC (“Westridge Group,” “Provider,” “we,” “our,” or “us”). By accessing or using the Data, Subscriber agrees to be bound by this Agreement. If Subscriber does not agree, they must discontinue use immediately.

1. Updates to This Agreement

Provider may update this Agreement at any time. The current version will always be available where this Agreement is published. Continued use of the Data after changes become effective constitutes acceptance.

2. Scope of Subscription

Provider grants Subscriber access to non-sensitive Data as described in the Marketplace Product Listing (“Data”), including any related materials (“Subscribed Assets”).

3. No Personal Data Collected

Westridge Group does not collect, process, store, or receive any personal information about Subscriber. All Data provided is non-sensitive.

4. License & Permitted Use

Provider grants Subscriber a nonexclusive, worldwide, non-transferable license to access and use the Data and create Derived Data. Subscriber may not resell, publish, redistribute, sublicense, or reverse engineer the Data.

5. Proprietary Rights

Data and all IP rights remain Provider’s property. Subscriber owns Derived Data except for the underlying Data.

6. Warranties

Data is provided “as is” without warranties except that it contains no personal or sensitive information.

7. Confidentiality

Subscriber must maintain confidentiality and prevent unauthorized disclosure.

8. Limitation of Liability

Except for willful misconduct, fraud, breach of confidentiality, or indemnification, each Party’s total liability is limited to the total fees paid by Subscriber in the prior 12 months. No Party is liable for indirect or consequential damages.

9. Indemnification

Subscriber shall indemnify Provider for misuse or violations of this Agreement.

10. Term & Termination

Either Party may terminate for material breach with 30 days' notice if uncured. Subscriber must delete all Data within 90 days following termination.

11. General Terms

Governing Law: New York. Notices may be electronic. No publicity without permission. Parties are independent contractors. Severability applies. This Agreement is the entire understanding.
